


SELF-TEST / DIAGNOSTIC (Optional)

(up to 54 watts)

- Microprocessor controlled state of the art self-diagnostic system
- Automatic 15 minute monthly and 90 minute yearly discharge tests
- Visual and Audible indicators for the following conditions:
 - Transfer failure
 - Charger malfunction
 - Defective battery
 - Burnt out lamp

RT - Remote test (Optional)

Allows user to initiate a momentary test of the emergency lighting from up to 20 feet away. Infra red remote (IRT) not included.
